

3/16/1268/LBC – Repairs to existing chimney stacks and balustrading, repair and refurbishment of existing roof lantern, repairs and alterations to fenestration, re-wiring, asbestos removal, provision of new bathrooms, new heating and hot water system, changes to internal layout and associated alterations, internal and external decoration and associated repairs, repair and infill front of existing pavilion to provide garden store. (Amendments to scheme approved under LPA Ref: 3/14/0762/LB) at Moor Place House, Much Hadham.

- Scale and size of the building proposed
- Inaccessibility of the garage itself – access would seem to involve driving / manoeuvring on adjacent private land.
