### 17/36. MINUTES OF THE LAST MEETING

RESOLVED that the minutes of the last meeting held on 7 March 2017 be accepted as a correct record of the proceedings and be signed by the Chairman.

### 17/37. REPORTS ON OUTSTANDING MATTERS

Report on outstanding matters received with the following updates:

Old Station Yard – possible that this may be decided under delegated powers. Decision from Cllr I Devonshire (EHC) would then be required regarding taking the application to EHC’s Development Management Committee.

Jolly Waggoners – following letter issued by the Chairman, meeting proposed between the Parish Council and one of the two partners that own the site but this has yet to be arranged. Meeting to be attended by the Chairman and Cllr I Hunt or Cllr W O’Neill.

Golf & Country Club – Chairman has seen the site but currently has no information on whether there are or are not any planning rights.

Moor Place gardens – clarified that the plan of title for the nature reserve sale excluded the extended gardens.

5 dwellings off Windmill Way/Millers View – wait for the outcome of the application for a further 8 houses. It was discussed that all the properties may have imperfect title given the section 52 issues surrounding the site.

Northleys – Cllr W Compton is currently drafting letter to EHC.
