Jolly Waggoners – update was provided as part of the Parish Council meeting on the 2nd May 2017. See minute 17/79.

Golf & Country Club – Chairman reported that there is a loophole allowing erection of temporary dwellings, i.e. Mobile Homes. Viability of this business will be identified in time.

5 dwellings off Windmill Way/Millers View – currently being built and re-highlighted that all the properties may have imperfect title given the section 52 issues surrounding the site remain untested.

Northleys – Cllr W Compton sent a letter to EHC. Although awaiting a response from the Head of Planning, a response from a Planning Officer was that EHC do not consider there to be any outstanding matters which are not compliant.
