<u>Gardens extending into nature reserve</u> – Cllr B Morris considers there is no legal evidence to describe, as a nature reserve, the land adjacent to Kettle Green Lane, and also no legal evidence to describe the newly enclosed land as garden. This will be checked and future reports amended if necessary.

<u>Golf & Country Club</u> – Cllr I Devonshire (EHC) provided an update as part of the Parish Council meeting earlier. This was that the photos provided by Cllr B Morris clearly showed the three static units, which had been advertised, do not meet the definition of 'mobile' and had been shared with the Planning Enforcement Team. An enforcement file remains open.

<u>Jolly Waggoners</u> – owner still proving difficult to contact to discuss issues. The Chairman is pursuing.

#### (ii) Objections raised on the following application:

3/17/2034/FUL – Conversion of barns to dwelling (as approved under 3/17/0089/ARPN) and erection of rear extension at Barn at New Barns Lane Much Hadham

Objection on the basis of:

- Appears to be at least a 25% increase in the useable floor space of the building (although the plans are not particularly helpful in assessing this) which would seem to be on the border of what is considered "limited extension" permitted by GBC3; and
- Need to consider whether to give effect to the extension amounts to a rebuild of the barn rather than merely its conversion (the latter requiring the use of existing structural walls etc). The original application for change of use was approved by EHC on the basis of a conversion.

**Vote:** all Cllrs present voted against this application.
