9. REVIEW OF BURIAL FEE FOR EX-RESIDENTS

Formal discussion on the need for an additional tier of fees to cover ex-residents as opposed to considering each case individually. Suggestion made that a sliding scale fee be introduced that considers time resident in the village.

Standing orders suspended and residents present asked for their views. View received that a sliding scale would be a good idea although potentially difficult to work out.

Standing orders reinstated.

Agreed that Cllr Mrs J Liversage and the Parish Clerk would develop a scale fee for consideration at the next meeting.

10. BURIAL GROUND NOTICE

Subject to inclusion of the website link for the fees and amending 7i. to reflect that the plot number could be engraved on the side of the headstone, it was RESOLVED to approve the updated burial ground notice.

Following question from Cllr B Morris, it was confirmed that how the Regulations could be enforced would be investigated by the Parish Clerk.
