MINUTES of the Much Hadham Burial Authority virtual meeting held on Tuesday, 6th October 2020, at 6:52 pm.

In attendance: no members of the public and apologies were received from F Forth, Parish Clerk who was unwell. It was noted that the meeting was being recorded to enable the minutes to be produced.

20/34. APOLOGIES FOR ABSENCE

20/37. MINUTES OF THE LAST MEETINGS

RESOLVED that the minutes of the last meeting held on 9 June 2020 be accepted as a correct record of the proceedings and be signed by the Chair.

RESOLVED that the minutes of the last meeting held on 4 August 2020 be accepted as a correct record of the proceedings and be signed by the Chair.

20/38. REPORTS ON OUTSTANDING MATTERS

The Chair confirmed that outstanding matters would be covered by subsequent agenda items. In addition, it was noted that the first interment into the new Garden of Remembrance at Perry Green Burial Ground had taken place.

20/39. RESIDENTS' COMMENTS

20/40. MANAGEMENT UPDATE

Cllr K Twort and the Clerk had inspected the burial grounds prior to the meeting, finding both neat and tidy. It was noted that fences at both grounds were in a similar state, excluding the section that had been repaired at Perry Green, and the entrance to St Andrew's Burial Ground was still uneven.

Following discussion, it was agreed to:

- obtain a quote from Weld Design (as they had repaired the Perry Green fence) to:
 - o clean and paint the fences at both Burial Grounds; and
 - refurbish the gate at St Andrew's Burial Ground so that it is always easy to open and close; and
- install "grasscrete" at the entrance to St Andrew's Burial ground to make that a flatter surface.

In addition, it was also agreed that the gravedigger be asked to ensure that soil spoil was kept levelled.

20/41. BURIAL GROUND EXTENSION

The plan to extend the burial ground at Perry Green was re-visited. Following discussion, it was agreed that Cllr Mrs J Liversage would informally discuss this with those currently farming the land.
