# 21/28. MANAGEMENT UPDATE

#### Inspection

Cllr Mrs J Liversage and the Clerk had inspected the burial grounds prior to the meeting. The grass needed cutting at both grounds, but it is possible that the inspection was undertaken prior to the next scheduled maintenance visit.

At St Andrew's Burial Ground, it was noted that Cllr B O'Neill had done a great job of removing the ivy from the boundary wall. Further work at St Andrew's was needed to remove the self-seeded sycamore tree from under the holly tree as well as the ivy from the low brick wall between the burial ground and the churchyard. It will be confirmed with the Rector that clearing this low brick wall is acceptable to the Parochial Church Council.

Finally, Cllr Mrs J Liversage stated that she was expecting the quote for the work on the metal gate and entrance way at St Andrew's Burial ground on Wednesday 2<sup>nd</sup> June.

### Perry Green extension

Prior to the meeting, the Clerk had issued a revised plan for the Perry Green extension.

Following discussion, it was agreed to extend the burial ground by one third of the land remaining, 44 m. Quotes are to be obtained now so that the work can be undertaken after the 2021 harvest. For all future burials, the grave is to be dug in a rectangular shape, as opposed to the 6-sided coffin shape being used recently, and any excess soil spoil is to be removed from the site, as in the future, no soil spoil pile will be allowed. The Clerk is to ensure that funeral directors are made aware of these new requirements.

Given the existing rate of usage, the extended part of the burial ground to be operational by 2027 although be prepared to access earlier if needs be.

#### Notes:

- Planning permission was given for the entirety of the burial ground site on 19<sup>th</sup> August 1959.
- Soil spoil from digging graves no longer to be piled up on site. Funeral Directors to be informed that this needs to be removed after each burial.
- Currently, 12 new plots available in existing ground subject to grinding out tree stump. Clerk to obtain quote

#### **TEXT OF LETTER TO FARMER**



The Burial Authority would be grateful if the land being returned to it could be made level and seeded with tough grass at the earliest suitable opportunity.


