Objection on the basis of:

- Over-development of original property when considered cumulatively with other extensions and buildings
- Purpose unclear is it ancillary to the residential use of the main building?

Vote: For 3
Against 4
Abstain 0

3/16/1712/FUL – Erection of five dwellings (1 detached and 4 semi-detached) with associated garages and access road on land off Windmill Way/Milliers View Much Hadham

Objection on the basis of:

- Failure to make adequate provision for an uninterrupted bat corridor
- Adverse impact on natural environment habitats contrary to s41 NERC Act, as identified in the Herts Ecological Network Mapping Project
- Impact on biodiversity, contrary to NPPF policy
- Breach section 52 agreement
- Development in the rural area beyond the Green Belt is against EHC planning policy

However, if approval is granted, s106 contribution should be sought in view of the windfall gain to the developer from developing a greenfield site in the rural area.

Recorded ballot requested by Cllr W Compton

It was unanimously agreed by all Cllr's present to object to this planning application.

Cllr B Morris asked that a request be sent to Cllr Ian Devonshire (EHC) that this application be put before EHC's Development Management Committee.

3/16/1895/FUL – Change of use of garage to annexe at Old Park Barn Perry Green Much Hadham

Objection on the basis of:

- No provision made for managing ecological risk given the biodiversity and wildlife in and surrounding the adjacent pond
- Appears to be the creation of a new dwelling
