### 18/136.RESIDENTS' COMMENTS ON CURRENT PLANNING APPLICATIONS AND APPEALS

# 3/18/2054/FUL - Kesten

Two residents outlined their concerns for the replacement of the existing bungalow with a 4 bed house and the following main points were made:

- replacement dwelling is not in keeping with the existing street scene, contrary to the District Plan (page 231);
- height and width of proposed gable end reduces sunlight into living space;
- ridge height is too high and property should remain as a bungalow, like its neighbours;
- increased depth on the 1<sup>st</sup> floor will impact on privacy in neighbouring garden; and
- concern that errors remain within the plans submitted, particularly in terms of the footprint of the existing property.

Following clarification, it was confirmed that the residents had been given an opportunity to discuss the application with the appointed Planning Officer from East Herts Council.
