#### 20/21. CURRENT PLANNING APPLICATIONS CONSIDERED

At the start of this agenda item, the Clerk reported that the following linked applications had been withdrawn on 3<sup>rd</sup> February:

3/20/0002/LBC - Proposed single storey rear extension at The Old Nurseries Widford Road Much Hadham – on the agenda for tonight's meeting; and

3/19/2526/HH - Proposed single storey rear extension at The Old Nurseries Widford Road Much Hadham – considered at the January 2020 meeting.

# (i) Support given to the following application:

3/20/0023/HH - Removal of door to ground floor front elevation and insertion of window; removal of window to side elevation and insertion of door at 27 Ash Meadow Much Hadham

Support application but would make this ancillary point to be addressed by condition or building regulations: the internal door arrangements show the doors clashing when both are opened, which is an accident waiting to happen. The doors should be hinged appropriately to avoid this risk.

**Vote:** all Cllrs present voted to support this application.

### (ii) Objections raised on the following application:

3/20/0003/HH - Erection of detached garage with room over at Watersdown Station Road Much Hadham

Objection on the basis that:

- it is a large building for 3 vehicles with games/hobby room above and will not be at all subservient to the house, being of a similar height and far closer to the street from which it will dominate the view of the property. It is sited well forward of the building line, which has otherwise been respected by all the neighbouring properties. The building would be side on to the street, presenting a blank gable wall. Roller shutter doors giving an industrial feel to the front elevation are proposed;
- there is a complete disregard for the requirement to preserve or enhance the Conservation Area – indeed it would be detrimental to the character of Station Road, with its spacious front gardens. Policy HA4 requires

development to "respect established building lines, layouts and patterns" and "be of a scale proportion, form, height, design and overall character that accords with and complements the surrounding area."; and

• no justification is provided as to why this application should be supported.

**Vote:** all Cllrs present voted to object to this application.

### (iii) Neutral view on the following application:

3/19/2631/FUL - Replacement 4 bedroom dwelling and erection of a car port at Ridgemont Widford Road Much Hadham

**Vote:** all Cllrs present voted to be neutral for this application.

# 20/22. EAST HERTS COUNCIL CONSULTATION

The Chair highlighted that East Herts Council are consulting, again, on an Affordable Housing Supplementary Planning Document (SPD). Following discussion, it was agreed that the Chair would draft a response to the consultation for approval via email and submission prior to the deadline of 27<sup>th</sup> February. The key element of the response will be that the SPD should include community-led housing as a source of affordable housing.
