MINUTES of the Much Hadham Parish Council Planning Committee virtual meeting held on Tuesday, 3<sup>rd</sup> November 2020, at 9:22 pm.

20/110. APOLOGIES FOR ABSENCE

20/111. DECLARATIONS OF INTEREST

## 20/112. CHAIR'S ANNOUNCEMENTS

The Chair stated that the Parish Council had objected to the planning application for a yoga centre on land south of Kettle Green Lane, as had a number of residents with 75 objections in total. There had also been some support (35), mainly customers of the business's other centre in London.

In addition, the Chair stated that there had been some ill-informed speculation about who owns the land, who the applicants are and what their true motives might be in an apparent attempt to mislead and worry residents. Worse still, some residents had been badgered to put in objections on the basis of this speculation or had been asked to justify why they hadn't put in an objection. This is not appropriate behaviour.

Finally, the Chair reminded those present that district planning decisions are made according to whether the proposals are compliant with planning policies. Objections submitted by the Parish Council concentrate on the absence of such compliance and do not simply repeat speculation. Over several years now, the Parish Council has demonstrated that this is the most effective way to get the results that residents want.

## 20/116. PLANNING ENFORCEMENT

Cllr D McDonald reported that a further meeting with East Herts Council had taken place on 28<sup>th</sup> October, following on from the previously reported meeting of 7<sup>th</sup> September. Those involved were himself, the Chair, East Herts Council's Head of Planning, and two Planning Enforcement officers who have been involved in the Moor Place Park Plot 12A and Nature Reserve enforcement cases. The purpose of the meeting was to discuss:

- the Parish Council's concerns regarding East Herts Council's failure to take effective enforcement measures in respect of Plot 12A and the Nature Reserve;
- ways in which the planning and enforcement process could be made more effective in the parish; and
- implementing structures for closer working relations and greater Parish Council input on local planning and enforcement matters in the future.

In discussing the Moor Place Park enforcement cases, the following points were made by the lead Planning Enforcement officer:

- both enforcement cases are still open and relevant landowners are being engaged with;
- less attention had been made to drafting planning conditions in the past which is causing the current issues;
- the Planning Department is understaffed;
- approximately 500 complaints are received annually, and enforcement action is only bought in respect of a very small number of them;
- almost no proactive monitoring is undertaken by East Herts Council with the majority of enforcement action being triggered by complaints from individuals (neighbours and others); and
- in relation to the Nature Reserve, a guiding principle which the Council follows in deciding whether to bring enforcement action is that of "expediency" i.e. whether the harm which will result from not taking enforcement action is sufficient to justify intervention. In response, the Parish Council representatives highlighted that failing to implement a required programme of tree planting was a clear breach of an important condition, bearing in mind that what was required to be created was a nature reserve.

Cllr D McDonald highlighted that he had raised, again, the possibility of East Herts serving what are known as s102 or s215 notices as an interim enforcement option to get these two specific sites tidied up. In addition, he noted that there was no support from East Herts Council to include time frames in planning conditions, with the suggestion that it was impossible to do so due to legal reasons and this will be followed up.

In terms of the future, the following points were made:

- both Plot 12A and the Nature Reserve would continue to be monitored by East Herts Council and the Parish Council would be informed as and when decisions are made as to whether or not to take enforcement action;
- a forum for regular bi-partite discussions and for "round table" discussions, involving other Parish Councils, to be established by Head of Planning;
- the Parish Council will supply a summary of suggestions on how the planning and enforcement process could be improved to the Head of Planning, for further discussion;
- the Parish Council will be afforded an opportunity to input into the East Herts
  Council's review and update of its Enforcement Strategy policy document which they
  are currently preparing;
- the Parish Council offered to assist in monitoring the implementation of planning conditions in our Parish so that, where appropriate, enforcement action can be taken in a timely way.

In summary, Cllr D McDonald stated that the meeting had been good in parts. Continued action will be required to ensure that effective action is taken by East Herts Council in respect of Plot 12A and the Nature Reserve and to set up the structures mentioned. This will enable the Parish Council to play a more effective role in the process and establish direct lines of communication with the Planning and Enforcement teams.
