21/46. APOLOGIES FOR ABSENCE

None.

21/47. DECLARATIONS OF INTEREST

Cllr S Smith declared an interest in agenda item 21/55:

3/21/1320/FUL - Erection of a hut to provide toilet facilities, kitchen and storage area; covered veranda for shelter for use of tennis club members at Much Hadham Lawn Tennis Club High Street Much Hadham

21/48. CHAIR'S ANNOUNCEMENTS

The Chair stated he had intended to comment on the problems being faced by East Herts Council's Planning Department but these had been covered by Cllr I Devonshire (EHC) in the preceding Parish Council meeting. In addition, he highlighted the following matters which are indicative of poorer performance:

- decline in response times in relation to correspondence;
- increased level of successful planning appeals East Herts was now statistically one of the worst performing Planning Departments in this respect; and
- an Annual Authority Monitoring report, demonstrating how well the District Plan
 was working, had not been produced since 2018/19. This report should include
 details on East Herts' housing land supply, previously reported at 5.6 years in the last
 report but currently unknown.

The Chair highlighted, as noted in the report, that a note on the further consultation for Harlow North (as it used to be known) relating to updated environmental submissions had been circulated to all Clirs after the last meeting with the conclusion that no further action was warranted.

Cllr D McDonald provided the following update on the outstanding planning/enforcement matters:

- meeting with Cllr I Devonshire (EHC) had taken place to discuss the outstanding issues, following which Cllr I Devonshire (EHC) had written to the Executive Member for Planning at East Herts Council offering his assistance – no response received; and
- a further email had been to the Executive Member for Planning at East Herts Council
 expressing the Parish Council's disappointment at the further lack of progress and
 requesting a meeting be arranged no response received.

The Chair reported that there was no new information available as a result of the appeal. Consequently, there was nothing to add to the existing comments already made by the Parish Council in respect of this application which would be forwarded by East Herts Council as part of the appeal process.

(ii) Objections raised on the following application:

3/21/1195/HH - Single storey rear extension with installation of a roof lantern, conversion of garage, replacement of garage door for window and repositioning of the first-floor rear window at Rose Cottage Ducketts Lane Green Tye Much Hadham

The basis of the objection is that:

- the property is within a Conservation Area and the extension does not preserve the special interest, character and appearance of the area in line with policy HA4; and
- conversion of the garage to a study reduces the nominal parking provision which could result in additional on road parking to the detriment of the Conservation Area and the Common.

Against 0
Abstain 1

3/21/1206/HH - Erection of garden room/Gym/living/work space at Baltimore Green Tye Much Hadham

The basis of the objection is that the proposal for a new outbuilding is contrary to policy GBR2 which only permits the replacement, extension or alteration of a building in relation to development in the rural area. In addition, there is no evidence to demonstrate how the proposal complies with policies HA4 or HOU11.

Vote: all Cllrs present voted to object to this application.

21/56. DATE OF NEXT MEETING
