Apologies for absence were received and approved from Cllr B O'Neill.

22/26. MINUTES OF THE LAST MEETING

Objection on the basis that the site appears too small to benefit from permitted development rights. Moreover, the proposal by virtue of its siting, scale, form and design would result in a discordant and unsustainable form of development that would have a significant adverse visual impact on the landscape character of the area and views of the site from all directions. The current enforcement action needs to be vigorously followed up by East Herts Council and the container removed.



Much Hadham Parish Council objects to this planning application. The basis of the objection is set out below:

The proposed construction of a cartlodge is directly adjacent to the public footpath that runs behind the almshouses. The Strategic Environmental Assessment prepared for the Neighbourhood Plan highlighted that, in relation to any proposed development of the land at the former Barn School, "The site provides an open and rural backdrop to the listed buildings, making a substantial contribution to the significance of their respective settings." The listed buildings referred to were "3 x Grade II-listed buildings (St Andrew's Church of England JMI School; Almshouses; The Barn School)". [The Barn School is now renamed as Hill House.]



The proposed siting of the cartlodge could be detrimental to the setting of the Almshouses, being only ~6m from their nearest elevation at its closest. Its positioning next to the public footpath FP22 presents to users the unremarkable side elevation of the cartlodge to a height of ~4.1m, twice the height of the present fence. No mention is made of what will happen to the trees that appear to be growing where the cartlodge is to be sited. It is disappointing that the supplied heritage

statement makes no mention of this proposal, which is within the curtilage of the Grade Illisted Hill House, and that the elevation drawings provide no measurements.

Moreover, the design and access statement (D&A) accompanying the application is extremely perfunctory. There is no explanation of how the proposed cartlodge is suitable for the site and its setting nor does it explain the design principles and concepts that have been applied to the development or demonstrate how the site's context has influenced the design. There is no discussion of how relevant District Plan policies have been considered – these would include inter alia GBR2, HOU11, DES4 and HA4.

Indeed, the Highways authority have refused to support the application because it is not shown that the cartlodge can be safely accessed and there is no consideration of the impact on the PROW, matters which a D&A should have addressed.

It is not demonstrated that the cartlodge preserves or enhances the Conservation Area, or that its siting is appropriate and complementary to the character, appearance and setting of the surrounding area. Given there already appears to be garaging facilities within the annexe, it is not explained why the cartlodge is required. Policy DES4 requires proposals to make the best possible use of the available land by respecting or improving upon the character of the site and the surrounding area, in terms of its scale, height, massing (volume, shape), orientation, siting, layout, density, building materials (colour, texture), landscaping, environmental assets, and design features, having due regard to the design opportunities and constraints of a site. The application is silent on all these factors.
