22/56. APOLOGIES FOR ABSENCE

Apologies for absence were received and approved from Cllr I Hunt and Cllr S Smith. In Cllr I Hunt's absence, Cllr D McDonald chaired the meeting.

22/57. <u>DECLARATIONS OF INTEREST AND REQUESTS FOR DISPENSATIONS</u>

22/58. CHAIR'S ANNOUNCEMENTS

22/59. MINUTES OF THE LAST MEETING

Approval of the minutes of the last meeting held on 26th April 2022 deferred to the next meeting as insufficient Cllrs from the last meeting were present to confirm accuracy.

22/60. REPORTS ON OUTSTANDING MATTERS

The report on outstanding matters was circulated prior to the meeting.

The Chair provided the following updates:

- <u>lack of effective monitoring and enforcement</u>: during May, Cllr I Hunt has had more contact with the other Parish Councils with similar issues and action to be taken is being considered;
- Plot 12 A Moor Place Park enforcement: the latest update from East Herts Council's (EHC) Head of Planning indicates that EHC's Legal team are reviewing the non-compliance with the issued notices. This could lead to prosecution;
- <u>nature reserve The Ley at Moor Park Place</u>: issue has now been resolved. The land has been sold to a local resident who intends to protect it from development and willing to be approached by other local residents if they wish to plant trees. In

- addition, it is believed that the strip of land at the bottom of The Ley has also been sold to friendly interests; and
- <u>Jolly Waggoners</u>: Cllrs I Hunt, D McDonald and K Twort held informal discussions with the owner and their architect on the 29th April regarding their plans.

Cllr K Twort highlighted that the Jolly Waggoners site had since been cleared.

22/63. RESIDENTS' COMMENTS ON CURRENT PLANNING APPLICATIONS AND APPEALS

3/22/0909/FUL - Change of use at Warren Park Heritage And Craft Centre

A resident outlined their concern that the planning application was proposing a change of use from craft to flexible use, detracting from the original intentions of the site, as stated in the original planning permission which restricted the site to craft use. For example, the proposal for a café/restaurant on site to reduce vehicle movements will not support the local community.

The resident also highlighted that the request for additional car parking spaces seemed at odds with the current minimal use of the car park – as evidence by a photo provided to the Committee.

Finally, the resident reported that planning conditions had not been met in terms of the landscaping requirements. The car park was supposed to be shrouded by hedgerows and have a grasscrete surface. The reality is that there is no hedging and the car park surface is shingle.

Vote: all Cllrs present voted to support this application.

Support given. However, it is understood that the original planning conditions have not been complied with in relation to the car park landscaping requirement and Planning Enforcement should review this.

(ii) Objections raised on the following application:

3/22/0618/HH – Re-consultation: Change of use of land from agricultural to residential garden, together with hard and soft landscaping at Uffords Barn Green Tye

Objection on the basis that the change of use does not comply with policy HOU12.

Vote: all Cllrs present voted to object to this application.

3/22/0899/FUL - Change of use of land to D2 (Assembly and leisure); erection of cricket school and creation of 17 parking spaces at Jobbers Wood Sports Pavilion Great Hadham Road Much Hadham

Objection on the basis that the incursion into the green belt for this indoor sport proposal does not accord with the exceptions detailed within the National Planning Policy Framework. Reference to the appeal decision relating to planning application 3/20/2355 for padel courts at Bishop's Stortford Tennis Club, an urban environment, is considered not to be apposite.

Vote: all Cllrs present voted to object to this application.

3/22/0949/HH - Partial demolition of roof to rear elevation; erection of two storey rear extension and part single storey rear extension at 2 Chapel Cottages Tower Hill Much Hadham

Objection on the basis that this extension fails to comply with policy HA4.
