23/1. APOLOGIES FOR ABSENCE

Apologies for absence were received and approved from Cllr K Twort.

23/2. DECLARATIONS OF INTEREST AND REQUESTS FOR DISPENSATIONS

23/3. CHAIR'S ANNOUNCEMENTS

The Chair reported that a trial would be starting next month where the agenda papers would include information on other planning applications that the Parish Council is not consulted on, mainly to do with permitted developments. The Clerk will be producing a schedule of this information.

23/4. MINUTES OF THE LAST MEETING

RESOLVED that the minutes of the last meeting held on 6th December 2022 be accepted as a correct record of the proceedings and be signed by the Chair.

23/5. REPORTS ON OUTSTANDING MATTERS

The report on outstanding matters was circulated prior to the meeting.

Cllr D McDonald provided the following updates:

- <u>lodge at Bluebell Farm</u> update from East Herts Council's (EHC) Planning Enforcement awaited;
- <u>classification of mobile homes/lodges in terms of the council tax base</u> the Clerk reported that EHC's Head of Revenues & Benefits had investigated and no issues were identified in relation to the lodges at the Great Hadham Golf & Country Club or Paddock Lodge on Chaldean Farm. The site visit for Bluebell Lodge had not yet taken place;

23/8. RESIDENTS' COMMENTS ON CURRENT PLANNING APPLICATIONS AND APPEALS

3/22/2377/FUL - The Vineries

A resident highlighted that although confirmation had been obtained that this planning application had been properly advertised by East Herts Council, it was felt that there was limited awareness of it within the local community. It was noted that no objections had been submitted as yet when a number had been submitted in relation to a previous planning application from this business.

In addition, a resident commented that this site was using its own vegetable waste for power generation as well as that sourced locally, according to the application. However, lorry movements with waste from further afield had been noted.

A resident stated that, in their view, very little space had been allocated to the office element given the size and scale of the proposal.
