24/1. APOLOGIES FOR ABSENCE

The Chair welcomed everyone to a new year.

# 24/4. MINUTES OF THE LAST MEETING

RESOLVED that the minutes of the last meeting held on 5<sup>th</sup> December 2023 be accepted as a correct record of the proceedings and be signed by the Chair.

#### 24/5. REPORTS ON OUTSTANDING MATTERS

The report on outstanding matters was circulated prior to the meeting.

The following updates were provided:

- affordable housing at Gilston Garden Town in essence, like for like information was not being compared when questions were raised about the reduction in the percentage of affordable homes. In addition, the project required more infrastructure which was being delivered earlier thereby reducing the scope for affordable housing. It was agreed no further action was require and the matter be closed;
- <u>8 Warren Place (Grandey's Place)</u> response from East Herts Council (EHC) awaited;
- <u>1 Danebridge Lane</u> the lack of obscure glazing still being investigated by EHC Planning Enforcement;

- <u>Junk Shop</u> the new owner has been informed by EHC that no planning application
  was submitted for the new shop. The Environment Agency do not intend to take any
  further action regarding the underground petrol tanks but some further questions
  have been asked;
- <u>field opposite Danebridge Cottage</u> no further information has been received from EHC. It was noted that further activity had been taking place, namely a bonfire and heavy machinery being used;
- <u>Plot12A, Moor Place Park</u> it was noted that EHC have closed this case.
   Cllr D McDonald will write a final letter outlining the Parish Council's disappointment at this action. Going forward, residents will keep the site clear and trim the hedges; and
- <u>Jolly Waggoners</u> a planning application has been made which has yet to pass EHC's validation checks in order to be added to the portal.

# Victorian Glasshouse at The Hall

The Chair reminded everyone that an issue had been raised at the preceding Parish Council meeting (Parish Council Minute ref: 24/9) regarding the dilapidation of the Victorian Glasshouse at The Hall.

Residents had raised this matter with East Herts Council's Planning Enforcement who had concluded that no further action was required, stating "The condition of the glasshouse poses no threat to the public as it is wholly within the private garden of Much Hadham Hall. It has therefore been assessed that the conditions observed are not expedient for any formal intervention at this time."

It had been agreed at the Parish Council meeting that the Parish Council Chair would draw the owner's attention to the concerns of residents regarding this matter.

#### 24/9. RESIDENTS' COMMENTS ON CURRENT PLANNING APPLICATIONS AND APPEALS

As a resident, Cllr B O'Neill reported that the landlord of The Bull Inn had handed in his notice to Punch Taverns. It was noted that poor handling of the pub's toilet renovation had been a factor.

Note – as part of the preceding Parish Council meeting, comments regarding The Bull Inn were made, in particular a resident's concerns that the related planning application was not being considered at East Herts Council's Development Management Committee. (Parish Council Minute ref: 24/9)
