24/25. APOLOGIES FOR ABSENCE

24/27. CHAIR'S ANNOUNCEMENTS

The Chair thanked Cllr S Smith for stepping in at short notice to chair last month's meeting, in the absence of both himself and Cllr D McDonald.

In addition, the Chair made the following comments:

- the agenda for East Herts Council's (EHC's) Planning Forum on the 13th March 2024 includes a discussion on the Village Hierarchy, as part of the Local Plan update. As the Chair cannot attend this Forum, Cllr D McDonald will aim to; and
- the planning application for The Bull Inn is being considered by EHC's Development Management Committee (DMC) at either its April or May meeting and the Chair intends to talk on behalf of the Parish Council at this meeting.

Note – The Bull Inn planning application was also discussed at the preceding Parish Council meeting – see Minute ref: 24/41 (ii).

24/28. MINUTES OF THE LAST MEETING

RESOLVED that the minutes of the last meeting held on 6th February 2024 be accepted as a correct record of the proceedings and be signed by the Chair.

24/29. REPORTS ON OUTSTANDING MATTERS

The report on outstanding matters was circulated prior to the meeting.

The following updates were provided:

- <u>8 Warren Place (Grandey's Place)</u> enforcement number allocated and an acknowledgement received that the matter is being pursued by EHC's Planning Enforcement;
- <u>1 Danebridge Lane</u> currently nothing further to report;
- <u>Junk Shop</u> confirmation from EHC that a planning application was not submitted to permit re-development of the premises. The owner apparently insists that a planning application is not required. In addition, it was noted that drainage may not be in place given the level of flooding on/near the site during the recent bad weather. Following further chasing, the Environment Agency has confirmed it will take no further action regarding the possible underground petrol tanks as there is no evidence of pollution;
- <u>field opposite Danebridge Cottage</u> nearby residents are encouraging EHC to seek an Injunction Notice which EHC Planning support but the EHC Legal team are less keen. Cllr I Devonshire (EHC) will add his support for the Injunction Notice. It is noted that the landowner has not registered ownership with the Land Registry. Since the last meeting, there has been limited activity on the field;
- <u>Plot 12 A, Moor Place Park</u> Cllr D McDonald has sent a final letter to EHC Planning, expressing the Parish Council's disappointment with EHC's decision not to enforce the original planning conditions; and
- <u>Jolly Waggoners</u> nothing further to report.
